

## Improving Our Health

In Park County, many community partners are invested in improving the health of our population. A true public health approach to improving health at the population level requires engagement from partners across numerous sectors including education, the justice system, local government, private businesses, healthcare agencies and non-profit organizations.

## Our Local Public Health System



When effective, the local public health system works to:

- Identify community health problems
- Mobilize community partnerships to identify and solve health problems and
- Develop policies and plans that support individual and community health efforts

A key vehicle for achieving the objectives above is a Community Health Improvement Plan (CHIP). The CHIP process in Park County brought together diverse partners from the local public health system to develop a plan for collective action to improve the health of our community. Without the involvement and active engagement of each and every partner, we cannot achieve our vision of a healthy community.

## Planning for Impact

In the spring of 2018, the Park County Health Department partnered with Livingston HealthCare, LiveWell49, Community Health Partners, the Livingston Public Schools, and Greater Gallatin United Way to develop a Community Health Improvement Plan (CHIP), The CHIP is a long-term, planning document that outlines strategies to address key health concerns in our community and improve the overall health of our population.

Working together, the lead organizations for the Park County CHIP convened a working group to develop the CHIP. This working group met three times in May and June of 2018, involving 41 partners from 28 organizations, who participated in a facilitated process to develop priorities and strategies to be included in the CHIP, This effort represents the first time a comprehensive community health planning process has been convened in Park County. This local effort builds on the work of the Montana State Health Improvement Plan by the Montana Department of Public Health and Human Services and national health planning efforts such as Healthy People 2020.

Participating CHIP partners were tasked with developing a data-driven plan, using results from recent community health needs assessment efforts which summarized the data related to population health in our county. CHIP participants were also instructed to consider the social determinants of health (the underlying social and economic concerns that affect health and create health disparities) and incorporate evidence based strategies for improving health on the population level.

The results of our community-wide planning process are contained on the following pages. CHIP planning partners were tasked with identifying:

- The county's most pressing health needs and priorities
- Assets and resources available to address those needs
- Strategies for collective action to address health priorities
- Metrics to measure progress in improving health in each priority area
- Community partners to lead identified strategies

Over the next few years, the CHIP lead organizations will work with community partners to implement the strategies included in this plan and monitor progress. For more information on this plan contact the Park County Health Department at (406) 222-4145.

## Improving our process

The information in this document represents the first community wide health planning process ever conducted in Park County, Montana. Throughout the CHIP planning process, we gathered information from participant stakeholders about how to improve our health planning processes in the future. Group members suggested the following ideas to consider when developing the community health data we use in the CHIP and when planning for the next CHIP process.

- Present community health data at the 1st CHIP planning meeting to help all group members have a baseline understanding of what the key health concerns in the community are based on available population level data
- · Consider the quality of community health data we have available in Park County and ask, "How do we improve it? What are the limitations?"
- · Consider developing more health surveys to improve the reliability of the data
- Ensure that future plans outline the limitations of the available data
- Because Park County has many seasonal jobs, consider weighting full time versus seasonal resident responses in community health surveys
- Work to measure full time growth and employment

The CHIP steering committee and the Park County Health Department staff will take these suggestions into consideration as they work towards coordinating future data-driven health improvement efforts in Park County.
